#### **2. Westshore CERT Presentation on Weather/Gas Outage Incident**

Chief Lenart and Service Director Mary Kay Costello presented on the Severe Weather/Gas Outage incident that took place in Rocky River. Details on the incident and how their CERT was instrumental in assisting the Fire Department and community were given.

Westshore CERT Team was activated to go "door-door" and assist residents. The County's mass-notification system Ready Notify was used to alert and get information out to residents.
